- 1 - Incoterms 2010 do not provide for obligations of stowage within a container. This issue should be dealt with within the sales contract
  - 2 - Seller may choose to sell product from their facility: FCA Sellers Facility. In this case the pre-carriage is required to be paid by the consignee
  - 3 - Only CIP and CIF require that Insurance be provided within the sales price. Insurance is not required within other incoterms
  - 4 - Charges are paid by Buyer or Seller depending on contract of carriage.
